The Private company Otokar Central Asia Limited, which provides the given website, is named as "we", "us" or "our" in these terms of use.

The website of Otokar Central Asia Limited <https://www.otokarcentralasia.kz> (hereinafter referred to as the "**website**") uses cookie to distinguish you from other users of our website and provide you with access to the content. This helps to provide users with positive experience from using the website and allows us to improve the website.

This Cookie Policy provides you with clear and complete information about the cookie we use and its purpose of use. To read the Privacy Policy that applies to users of the website, please read our Privacy Policy.

What are cookies?

Cookies are small fragments of data stored in text files that are stored on your computer or other device when downloading websites in your browser. They are widely used to "remember" you and your preferences, either for one visit (through a "session cookie") or for repeated visits (using a "permanent cookie"). They provide consistent and efficient use experience for visitors and perform important functions, for example, allow users to register and remain on the system. Cookies may be set by a website you visit (known as "first party cookies") or by third parties, such as those that provide content or provide third party cookies.

How we use cookies?

We use cookies for various purposes. Some cookies are required for technical reasons; some make it possible to personalize the experience of use for both visitors and registered users; some allow to display ads from selected third-party networks. Some of these cookies may be installed when the page is loaded or when the visitor performs a specific action (for example, by clicking the like or subscribe button).

Types of cookies

Cookies may be either "permanent" or "session" cookies. The website uses permanent cookies.

Consent to the receipt of permanent cookies of the text file is sent by the web server to the web browser, which allows us to collect and analyze (on an anonymous basis) the traffic and use of the website, monitor the system and improve operational performance, for example, store your preferences to improve your subsequent visits. It will not be automatically deleted when you close your browser, but it will be saved by the browser and will remain valid until the expiration date (unless the User deletes it before the expiration date).

The full list of cookies we use is given in the table below. This list (together with the rest of this Policy) may change from time to time.

The cookies we use on our website can be divided into the following categories:

- Strictly required cookies - required for website operation and cannot be disabled on our systems. As a rule, they are installed only in response to your actions, such as configuring the level of confidentiality, logging in to the system or filling out forms.
- Analytical and operational cookies - allow us to count the number of visitors and traffic sources in order to assess and improve the performance of our website. They can be installed by us or third-party providers and collect information on how visitors use the website and which pages, or videos visit most often.
- Functional cookies - allow the website to provide enhanced or more personalized features based on the history of your interaction with it. They may be installed by us or by third-party suppliers whose services we have added to the pages of our website.

- Target and advertising cookies - our advertising partners can install on the website. Such companies may use them to create a profile of your interests and to display appropriate advertisements on other websites.
- Social network cookies - Set up by social media services (such as Twitter, LinkedIn, Facebook) that we've added to our website and allow you to share our content with your friends and other users. They can track your actions.
- on other websites and create a profile of your interests. This can affect the content of other websites you visit and the messages you see on them.
