

## Personal Data Processing Agreement

I hereby give my consent to the collection and processing of my personal data to the Private Company Otokar Central Asia Limited (BIN 191140900091), located at the following address: Republic of Kazakhstan, Nur-Sultan, Esil district, st. Mangilik el 55/16, office 339-340 (hereinafter - "**Operator**"):

### 1. General provisions:

- 1.1. This consent to the collection, processing and storage of personal data (hereinafter - "**Consent**") is aimed at protecting my rights and freedoms.

### 2. Information on the processing of personal data

- 2.1. The Operator can process personal data to achieve the goals set out in clause 3.1. of this Consent.
- 2.2. The Operator can process personal data in automated and non-automated ways, using computer technology and without using such means.
- 2.3. Actions for the processing of personal data include the accumulation, storage, modification, addition, use, distribution, depersonalization, blocking and destruction.
- 2.4. This Consent also applies to cross-border transfers of personal data and includes the transfer of personal data to third parties.

### 3. Processing of personal data

- 3.1. The Operator can process personal data in compliance with the legislation of the Astana International Financial Center with the purpose of:
  - 3.1.1. acceptance of requests;
  - 3.1.2. notification of new goods, special promotions and offers;
  - 3.1.3. sending an electronic cash receipt;
  - 3.1.4. information distribution.
- 3.2. The information user shall process the personal data by taking specific actions on this site "[[www.otokarcentralasia.kz](http://www.otokarcentralasia.kz)]" including, but not limited to registration in the personal account, subscription to the mailing list, and also the marking of consent in accordance with the Agreement.
- 3.3. The information user shall process the personal data no longer than is required for the purposes of personal data processing, unless otherwise is stipulated by the legislation of the Astana International Financial Center.
- 3.4. The Information user may process the following personal data:
  - 3.4.1. surname, first name, patronymic;
  - 3.4.2. contact telephone number;
  - 3.4.3. e-mail address.

### 4. My rights

- 6.1. I have a right to:
  - 6.1.1. request the provision of personal data used;
  - 6.1.2. revise (amend) his personal data if they are incomplete, obsolete, inaccurate;
  - 6.1.3. withdraw his/her consent to personal data processing;
  - 6.1.4. protect their rights and legitimate interests, including compensation of losses and compensation of non-pecuniary damage in court;

### 5. Final provisions

- 5.1. The Agreement shall be governed by and construed in accordance with the laws of the Astana International Financial Center. Issues not regulated by the Agreement shall be resolved in accordance with the legislation of the Astana International Financial Center.
